

#### New Paper Co-Authored by BPA Member

Summary of article: Materialized Oppression In Inpatient Psychiatric Design, published in April 2023 in The American Journal of Bioethics, seeks to comment on the atmosphere of detention versus rehabilitation which the authors posit reinforced oppression in the people it aims to serve. Former BPA Secretary and Member-In-Training Trustee, Topaz Sampson-Mills co-authored this paper with fellow psychiatry colleagues. Dr. Sampson-Mills is also referenced in the article pointing out the higher incidence of Black Americans experiencing disproportionately higher fatalities and other poor outcomes when law enforcement is involved in psychiatric emergencies. The authors implore for better collaboration with law enforcement agencies in handling psychiatric emergencies. Feel free to refer to the article for more details.

#### **One Psychiatrist's Perspective and an Invitation**

In 1994, 10 miles from Covenant Christian School in Nashville, TN, my 13YO son saw his classmate toss a gun in the cafeteria trash can after he accidentally shot and killed a fellow student; the city and nation were left reeling. Several days later, I arranged to escort him and a group of his classmates to have a conversation with then-Tennessee Governor Ned Ray McWherter to share their horrific experience and recommendations for gun control measures from their early-adolescent perspective. He listened politely, thanked them for coming, and as we were leaving, privately scolded me for being irresponsible by giving them hope that more restrictive gun laws could ever be a reality. Since that time, laws have become significantly less restrictive, making it even easier for the March 27, 2023 incident to be carried out than in 1994. Sadly, there is still evidence of psychological trauma in my now-42 YO son's life.



In response to viewing the recent SWAT team body cam footage, weapons drawn walking down school hallways, with the distant rapid-fire of an assault rifle, I wept for the terrifying world we have created for our children and grandchildren to inhabit; I wept for the collective failure of our nation to provide one of the most basic components necessary for healthy child development – a sense of security and safety; I wept, realizing that the strategies offered up to decrease gun violence will not change the hearts and minds that drive the ongoing gun control stale mate in the U.S.; and I wept for the ways that too many children are terrorized by the greed that extracts basic resources from their families and neighborhoods, its own kind of violence.

...but I have dried my tears, and **extend an invitation to you to join the BPA Policy and Governmental Affairs Committee**. We must muster our collective brain trust to think outside the box and disrupt the status quo. If there are solutions to be found for this and other problems perpetuating Black suffering, they will come from us and other like-minded organizations. #### **Disparities in Access and Quality of Obesity Care**

Hello Good People, I wanted to share an article that I authored on the *Disparities in Access and Quality of Obesity Care* which greatly impacts Black Americans. Stigma and bias greatly impact access to care for obesity and also mental health treatment and this leads to many complications. Here is a brief summary of the article [https://www.sciencedirect.com/science/article/pii/S0889855323000249 ?dgcid=author]:

"Obesity is a chronic disease and disproportionately affects racial and ethnic minorities and, most severely, Black persons with obesity. Health inequities affect many populations, including historically disadvantaged populations, persons living in rural areas, people with disabilities, and



marginalized racial and ethnic groups. Many factors lead to this, including limited access to quality obesity care and socioeconomic factors, such as living in an obesogenic food environment or experiencing frequent microaggressions and racism, which can ultimately increase chronic stress and the development of obesity. Overwhelming data support genetic and environmental causes, but many blame individuals with obesity for their weight status.

Weight stigma impacts many areas of life for people living with obesity, including the quality of health care they receive. We should provide adequate access to obesity care to all those affected by the disease. Education about obesity, including management, weight stigma, and disparities in care, should be included in the education and training of all healthcare professionals. Every patient with obesity should be offered all appropriate treatment options regardless of age, race/ethnicity, or socioeconomic status."

I've also included a picture of my recent presentation with the National Minority Quality Forum's Leadership Summit as a previous 40 under 40 Leader for Minority Health 2022 recipient where I presented on a panel about the impact of obesity and innovations in the future that will help lessen health disparities. My hope is to continue to work in the intersection of obesity, lifestyle medicine, and psychiatry to combat bias and stigma that worsens health outcomes for Black people and marginalized. I have also been accepted to Yale SOM EMBA Class of 2025. Keep rising. Wishing you all the BEST in peace and happiness.
