LaRissa Chism Buggs, MD, FAPA (University of Michigan, '97) is board certified in both Adult and Forensic Psychiatry and brings over two decades of experience in clinical practice and community mental health leadership. She is the co-founder and medical director of Cultivating Life Clinic, a charitable safety-net mental health organization dedicated to providing culturally competent, faith-informed care to uninsured and underinsured populations in Indiana. The clinic also operates a "street psychiatry" clinic serving individuals experiencing homelessness. Dr. Buggs is also a cofounder of The Nexus Center, a multi-faceted community wellness center that houses the clinic and supports educational, nutritional, and economic empowerment initiatives. In addition, she provides telepsychiatry services through Avel eCare and maintains a private forensic psychiatry practice offering expert evaluations and consultations.

A member of both the American Psychiatric Association (APA) and the American Academy of Psychiatry and the Law (AAPL), Dr. Buggs' clinical work has centered on community and public psychiatry, with a strong commitment to reducing stigma and improving access to care for underserved Black communities. A proponent of the power of presence, she believes that meaningful representation and inclusion strengthen both the profession and the communities psychiatrists serve.
